

## **Hannahville Indian School/Nah Tah Wahsh, PSA**

The Board of Education for Hannahville Indian School/Nah Tah Wahsh, PSA is in search of a new superintendent.

The Hannahville Indian School/Nah Tah Wahsh, PSA is located in eastern central Menominee County of the Upper Peninsula. In 1976, the Hannahville Indian School was established to address the needs of Potawatomi students while teaching them about their culture and history. In 1995, the Nah Tah Wahsh, PSA was established to serve native and non-native students. Today the Nah Tah Wahsh Soaring Eagle PSA serves approximately 175 students in grades K-12 with an additional 90 students in our birth through age 5 program. The district also provides a Family and Child Education program (FACE) which has received national recognition as a model program and serves as a valuable asset to the community encouraging and promoting adult education and college programs by young parents. The district campus is state-of-the-art providing a cafeteria, library, gymnasium, elementary wing, high school wing, industrial arts wing, culture department, child care center, early head start and head start classrooms, extensive playgrounds, two computer labs, youth lounge, dance instruction room, soccer field, and commercial scale aquaponics facility. The youth center, directly attached to the cafeteria and gymnasium, is the hub of the after school, weekend, and summer activities. It also houses our Youth Services Department which includes a youth employment/training program and a 21<sup>st</sup> Century Learning Center Program.
