Bloomington Public Schools is located in Bloomington, Michigan in Van Buren County and has a three-year average student population of 1,133. The schools are located on approximately 45 acres of land and are composed of Bloomington Middle and High School, Bloomington Elementary, and Pullman Elementary. Pullman Elementary is 13 miles away and is located in Allegan County. The school district has a very clean, well-maintained physical environment.

After a successful bond project in 2003, the District built a new high school and added classrooms with state-of-the-art music rooms and computer labs at both elementary buildings and a regulation-size gymnasium at Pullman Elementary. The District had another successful bond project in 2008 and added an 8-lane all-weather track and turf football and soccer field. Our community continues to support our District and enhance our facilities for students.
