## Posting for Superintendent

The Board of Education for Carrollton Public Schools is in search of a new superintendent. This is only the preliminary posting; a detailed profile of the ideal candidate will be added at a later date. We encourage interested applicants to refrain from applying until the profile is posted.

Carrollton Public Schools is located on the north-east side of Saginaw County. Interstate-75 and 675 run near the district boundaries and provide easy access to the district trunk roads.

Carrollton Public Schools has a total of 6 buildings in the district and 20 Shared-Time buildings serving students PK-12. In the district, there is one elementary school, one middle school, two high schools, and a daycare and early childhood program (GSRP). Carrollton is a 1:1 district K-12 and provides several supplemental online platforms for teacher and student use in addition to the base curriculum. For the 2021-22 school year, 62% of the students were schools of choice, making it one of the largest school of choice districts in the state of MI.

**Application Procedure**

The negotiated salary and benefits package will be commensurate with the chosen candidate’s experience and qualifications.
