

BREITUNG TOWNSHIP SCHOOLS POSTING

The Board of Education for the Breitung Township Schools is in search of a new superintendent.

The Breitung Township School District is located in the city of Kingsford, part of the Upper Peninsula of Michigan. The central location of the district offers many unique and special outdoor and cultural activities. Outdoor recreational activities are available year-round due to the unique and beautiful geographical location. The Great Lakes, many beautiful inland lakes, challenging golf courses, and the famous Pine Mountain Ski Jump are only a few of the exceptional activities offered by the area. In addition, many local artisans offer unique insights and opportunities to experience local and native cultures that make the Upper Peninsula special. In addition to tourism and recreation, industries of note include several major manufacturing businesses, Ford Airport, healthcare services, paper mills, timber products, technology-based businesses, and many small well-established businesses.

The Breitung Township School District is home to the Kingsford Flivvers and provides services to students in three modern state-of-the-art buildings. Woodland Elementary School serves Early-Kindergarten to fourth grade and also houses the Woodland Child Care Center which provides outstanding quality childcare for children 2 ½ to 11 years of age. The expansive single-floor building sits on 26 acres of land with 3 separate playgrounds, basketball courts, a soccer field, a baseball diamond, and open space for play. The building design concept is based on classroom pods anchored by the library/media center with a separate wing housing the cafeteria and gymnasium. The Kingsford Middle School is a two-story structure connected to, but separate from, Kingsford High School. Both are part of a 30-acre complex containing Flivver Field, practice field, field house, tennis courts, KMS Field, multiple parking lots, and the maintenance building/garage. The district offers state-of-the-art technology access with continuously upgraded technology devices and services to students at all academic levels.
