## Location

Frankenmuth School District is located in Frankenmuth, Michigan — a vibrant and historic community known for its German heritage, tourism, and strong civic pride. Often referred to as “Michigan’s Little Bavaria,” the city blends small-town charm with unique cultural attractions and high community engagement. Frankenmuth is approximately 25 minutes southeast of Saginaw and under two hours from Metro Detroit and Lansing.

The district serves approximately 1,350 students in grades PreK–12 and is deeply rooted in a tradition of academic excellence, student achievement, and strong family and community partnerships.
